1. COVERAGE

All students belonging to Scheduled Caste/Scheduled Tribe/Physically Challenged categories pursuing 2 years full time MBA/PGDBM in Human Resource Management/Finance Management/General Management from any IIMs, XLRI and FMS, shall be eligible to apply for the NTPC Scholarship.

2.0 SCHOLARSHIP: COMMENCEMENT, NUMBER, AMOUNT, DURATION AND.

- 2.1 The Scholarship Scheme shall commence from academic session 2014-15.
- 2.2 The number of scholarships in various disciplines of MBA/PGDBM will be decided by the management from time to time.
