works for education and welfare work of the society.

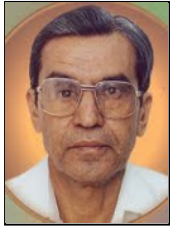
7. any income, property or fund shall be entrusted to other trust having same objectives.
