1.0 <u>OBJECTIVE OF THE SCHEME</u>

2.0 <u>COVERAGE</u>

- 4.5 The application must be accompanied by a Caste Certificate issued by the prescribed Authority, in the form prescribed by the Govt. Format of the Certificate , alongwith a list of authorities empowered to issue SC/ST Certificate is attached. In case of Physically disabled students, the application must be accompanied by a disability certificate issued by an appropriate authority notified for this purpose, in the format prescribed.
- 4.6 It will be responsibility of the Institute to verify the Caste/Disability Certificate.
- 4.7 The NTPC Scholarship will be subject to the continuous satisfactory performance and good conduct during the course.
