# **Introduction to the Trust**

Akash Memorial Charitable Trust was established on 24 Sep 2005. The Trust has been formed in the memory of Akash Saxena, an outstanding human being and student of computer engineering from National Institute of Technology, Jalandhar, whose brilliant life was cut short by an unfortunate accident at an early age of twenty years. The Trust has been registered under/has obtained sanction for the following:

- Registered under the Indian Registration Act, vide Registration No. IV/349 dated 24.09.2005.
- Exemption from Income Tax under Sec 80G, vide O/o The Commissioner of Income Tax letter No. F. No. 58(85)/Tax Exemption/CIT-GZB/2010-11/1016 dated 21.06.2010.
- Foreign Contribution Regulatory Act (FCRA) Registration No. 1374000024, vide their letter No. II/21022/73(0276)/2009-FCRA-IIdated 26.08.2011.

#### **Objectives of the Trust**

The main objective of the Trust is to impart basic computer training through Virjanand Akash Computer Kendra. The Trust has also been actively involved in providing medical relief to the needy, scholarships to deserving students, aid and support to orphanages and homes for the aged, granting relief and assistance to victims of natural and man-made calamities and in other similar social welfare causes.

# **Activities of the Trust**

## Virjanand Akash Computer Kendra

Virjanand Akash Computer Kendra was established on 03 Jun 2007 for imparting basic computer training to underprivileged and handicapped children, housewives and senior citizens in Arya Samaj, Dayanand Saraswati Marg, Sector-29, Noida-201301. The Kendra has so far trained more than 2000 students and some of them have even been employed in various reputable companies.

#### **Adoption of Orphans**

The Trust has adopted two children of SOS children village, Faridabad since 2005 and takes care of their all round development, through sponsorship of education, medical and food.

# World Disability Day

Every year, on the World Disability Day, we organize various competitions like painting, dancing and fancy dress, for the special children, in order to provide encouragement to them, bring out their latent talent and to generally see a smile on their faces. The function is organized at the Sai Amrit Masonic Spastic School, Sector 29, Noida, where such children from other institutions are also invited.

#### Scholarships

The trust has also taken up the responsibility of monetary assistance for education of poor children.

- A scholarship of Rs. 10,000.00 has been instituted at NIT, Jalandhar that is given to the topper of sixth semester in Computer Science.
- A rolling trophy has been instituted, with monetary remuneration, for outstanding performance in mathematics in class X at Air Force Bal Bharti School, Lodhi Road, New Delhi.
- A trophy with remuneration is awarded to a student of primary wing of the same school, for achievements in extra-curricular activities.

## Akash Computer Kendra

On persistent requests from the honorable senior citizens, the Trust has established Akash Computer Kendra at Jalvayu Vihar Community Centre, with effect from 02-08-2011 to provide basic computer training and use of Skype and Facebook to senior citizens.
