Kind attention of the Head of Institutions is invited on the subject mentioned above,

2. It is informed that the enclosed notification for the Award of Scholarship under Puducherry State Post Matric" Scholarship scheme for the year 2016-2017 may be arranged to be displayed in the Notice Boards and may also be announced to the students. It is also informed to send the requirements of scholarship applications on fresh & renewal immediately.

3. They should ensure that the application forms are supplied only to the students studying 11<sup>th</sup> std. who have secured not less than 60% of marks in the qualifying examination of SSLC / Matriculation. Similarly, for renewal, the students should have secured not less than 50% of marks in XI std.

3. The Head of Institutions should scrutinize all the applications and send only the eligible applicant in all aspects along with checklist on or before **30-09-2016**. Incomplete and ineligible applications should be rejected at their levels.

4. The Head of Institutions are requested to send a proposal in the prescribed proforma as given below alongwith application of eligible students.

**NOTIFICATION**

Applications are invited from the candidates who are Indian citizens and residents of the Union Territory of Puducherry and who have secured at least 60% of marks in the qualifying examinations of Matriculation/SSLC in the academic year 2015-2016 for sanction of the following scholarship in the year 2016-2017.

Name of the Scheme	: Pondicherry State Post-Matric Scholarship Scheme

Parental income limit	: Rs.75,000/- per annum
Last date for submission of application forms to the Head of Institution	: 20-09-2016
Last date for submission of application forms to this Directorate by the Heads of Institutions	: 30-09-2016

For application and further details, the students may contact their Head of Institution.

Amount of Scholarship under the Pondicherry State Post Matric Scholarship Scheme is Rs.600/- per annum @ Rs.60/- per month for 10 months for day scholars and Rs.1,000/- per annum @ Rs.100/- per month for 10 months for hostellers will be granted to Higher Secondary students.

**General Conditions of Eligibility**

- a) The candidates must be citizens of India and belong to the Union Territory of Puducherry either by birth or by domicile.
- b) The candidates who have passed the qualifying examination in their first attempt only will be eligible for consideration.
- c) The candidates are to be the students of Matriculation / SSLC schools.
- d) The candidates who have appeared as well as passed the qualifying examination in a year prior to 2015-2016 will not be eligible for consideration.
- e) The candidates who have passed the qualifying examination in first class or secured not less than 60% of marks in the qualifying examinations of SSLC/Matriculation are eligible for consideration.
- f) Income of their parents/guardians should not exceed to Rs.75,000/- per annum.

- g) In case of non-salaried persons such as businessmen, landlord / agriculturists and self-employed, etc., no standard deduction will be allowed and their entire gross income will be taken into consideration for computing their annual income.
- h) Separate income affidavit should also be furnished in case of the candidate's father and mother both of them doing business / on daily wages or running petty shops etc.
- i) It may also be ensured that the students once selected and recommended for this scholarship are not recommended again for any other scholarship

#### **Mode of Applying**

The candidates studying in the Government Institutions of the Union Territory of Puducherry who wish to apply for fresh scholarship for the year 2015-2016 may obtain the application forms from the respective Head of Institutions by remitting Rs.2/- and the students of Aided and Private Schools may get the application forms from the cashier of this Directorate on remitting Rs.2/-. The applications should be submitted to the Head of Institutions on or before **20-9-2016.**

Applications received after 30-09-2015 from the school concerned will not be considered on any account. Incomplete applications will be rejected without any consideration.

Students should take utmost care in filling up the forms to avoid rejections and they should see that their applications are received by their Heads of Institutions / Directorate of School Education within the scheduled time.

#### **RENEWAL OF SCHOLARSHIPS**

To get the Scholarship on renewal, the students should have been secured not less than 50% of marks in XI std. Further the Head of Educational Institutions are requested to collect the Annual Progress Report forms from this Directorate for renewal of Scholarship for the year 2015-2016. The last date for submitting the renewal proposal is fixed as **30.09.2016.**
