- Family Income Limits :
  - For Cat 'A' scholarship - BPL Certificate.
  - For Cat 'B' ITI Students - No Income Certificate will be required.
  - For those in employment - Rs.4.00 Lac per year. Certificate issued by the Employer.
  - For all others - Rs.2.50 Lac per year. Income Certificate obtained from the competent authority of the area including Patwari, Panchayat Head, BDO, any Gazetted Officer, any Retired I A S, I P S or I R S Officer.

- A student should apply for this scholarship only once in the duration of the course.

- The student should not be getting any other scholarship from any other source.
- Scholarship shall be discontinued after the student crosses 30th year of age.
