### NOTIFICATION

As per the decision of the 93<sup>rd</sup> General Council meeting held on 24<sup>th</sup> March 2018, the GC committee has decided to introduce scholarship scheme for the legal heirs of the registered pharmacists in the state of Karnataka, who pursue their pharmacy education (D.Pharm, B.Pharm, M.Pharm, and Pharm.D).

**Introduction:** Karnataka State Pharmacy council (KSPC) was established in the year 1968 as per the Pharmacy act 1948. KSPC right from its inception started to function and serve the profession of Pharmacy with utmost dedication and sincerity. KSPC pioneered in adopting innovative methods for serving the profession and became a model for other states of the country. KSPC in its pursuit to serve and extend the helping hand to practicing pharmacists, set up a Drug Information Center published many books to assist pharmacists. In addition a Social Security Scheme named as Karnataka Pharmacy Council Registered Pharmacist Welfare Trust (KPCRPWT) has been introduced by the Council with the intent of providing financial stability for nominees of Registered Pharmacist.

**Objective:** To encourage and financially support legal heirs of Registered Pharmacists to pursue Pharmacy education and to continue the practice of profession.

#### Scholarship Details

| Sl. No. | Course name        | No.of Scholarships per year | Scholarship amount/student/ year |

| 01      | D. Pharm (2 years) | 02                          | Rs. 10000                        |
| 02      | B. Pharm (4 years) | 02                          | Rs. 20000                        |
| 03      | M. Pharm (2 years) | 02                          | Rs. 20000                        |
| 04      | Pharm.D (5 years)  | 02                          | Rs. 20000                        |

The scholarship will be the amount mentioned above or the exact fee paid, whichever is less.

#### Eligibility and Criteria for selection:

01. The renewal status of Registered Pharmacist must be upto date / current.
02. He/she shall be legal heir of the Registered Pharmacist of Karnataka.
03. He/she shall secure admission to D. Pharm, B.Pharm, M.Pharm and Pharm D courses in any institutions of Karnataka, recognised by Pharmacy Council of India.
04. Merit in PUC will be considered for selection for scholarships for D.Pharm Category.
05. CET ranking and score will be considered to select candidates for scholarships to B.Pharm, Pharm D categories.
06. PG CET ranking and score will be considered to select candidates for scholarships to M.Pharm categories.

#### Conditions of the scholarship Scheme:

01. The scholarship will be paid to the selected candidates for period of the course, provided he/she shall pass all the subjects in that academic year or in both the semesters of that year with first class. If the candidate fails to do so, his/her scholarship will be terminated for that academic year. If he/she passes in the next academic year, his/her scholarship may be reinstated.
02. The candidate shall apply for the scholarship in the specified application format available on the KSPC website.

03. If a candidate is unable to attend the annual or semester examinations owing to illness and or on account of any unforeseen circumstances, the scholarship may be considered for next academic year (the candidate shall submit relevant supporting document in this regard).
04. The scholarship amount mentioned for a particular category will be given through cheque only after producing proof of admission.
05. The scholarship for his/her legal heir will be withheld for that year in case the Registered Pharmacist fails to renew his/her registration annually. It may be continued after renewal of the registration without arrears.
06. GPAT qualified candidate receiving AICTE fellowship is not eligible for KSPC scholarships.
07. In case of death of the Registered Pharmacist, the scholarship will be continued to the candidate till the completion of the course.

**Documents to submit along with the application:**

01. PUC marks card – 1<sup>st</sup> and 2<sup>nd</sup> Year
02. CET/PGCET rank letter
03. Proof of admission and fee paid receipt
04. Registered Pharmacist's Certificate
05. Proof of relationship with Registered Pharmacist
06. Self-declaration (in specified format)

**Documents to submit for continuation of scholarship:**

01. Attendance certificate issued and attested by the Principal / Dean of the institution.
02. Marks card issued by the University/Board of examining authority/competent authority attested by the Principal / Dean of the institution.
03. Fee paid receipt attested by the Principal / Dean of the institution.
04. Registered Pharmacist's Renewal Fee Receipt & Renewal Note.
05. Bank details like Bank Account No., Bank Name, Branch, IFSC Code
