<b>Fee</b>	:	<b>Rs. 94,500 + 17,010/- (GST @ 18%) = Rs. 1,11,510/-</b>
<b>I<sup>st</sup> Installment</b> (At the time of admission)	:	<b>Rs. 50,000 + 9,000/- (GST @ 18%) = Rs. 59,000/-</b>






1. \* **GST Tax Applicable** is as per Government Rules and Regulations.
