Scholarship & Education Loan for meritorious students belonging to Minority Communities
(Muslim, Christian, Sikh, Buddhist, Parsees and Jain)



PRE-MATRIC SCHOLARSHIP (FOR CLASS I TO CLASS X)

- Students studying in classes I-X in recognised institutions having UDISE code are eligible.
- The student must have passed the last examination with at least **50%** marks, except in class I.
- Annual family income of the applicant should not exceed **₹1.00 lakh**.
- Students will submit Photocopy of Bank Pass Book having account number & IFSC details, Annual family Income certificate issued by Pradhan/Councillor/MLA/Gazetted officer etc.) along with the print out of online application to the institution.

POST-MATRIC SCHOLARSHIP (FOR POST MATRIC CLASSES)

- Students pursuing Higher Secondary, ITI, DIPLOMA, GRADUATION, POST GRADUATION, M.PHIL, B.ED etc. courses from recognised institution having UDISE/AISHE/NCVT code are eligible.
- Student must have passed last examination with at least **50%** marks
- Annual family income of the applicant should not exceed **₹2.00 lakh**
- Students will submit Photocopy of Bank Pass Book having account number & IFSC details, Annual family Income certificate issued by Pradhan/Councillor/MLA/Gazetted officer etc.) along with the print out of the online application to the institution only.

MERIT CUM MEANS SCHOLARSHIP (FOR TECHNICAL & PROFESSIONAL COURSES)

- Students pursuing Under-Graduate/Post-Graduate level of Professional/Technical Courses in recognised institution under recognised Universities of West Bengal and other recognised Technical/Professional course at Universities of other states of India having AISHE code are eligible to apply.
- Student must have passed last examination with at least **50%** marks.
- Students may get full course fee in case of listed institution like IIT, IIM, NIT, NIFT, IIIT etc. (as per list of institutes available in www.wbmdfc.org).
- Annual family income of the applicant should not exceed **₹2.50 lakh**
- May be required to upload the original scanned documents.
- Students will submit all relevant documents along with the print out of the online application to the institution only.

SWAMI VIVEKANANDA MERIT CUM MEANS SCHOLARSHIP SCHEME FOR MINORITIES (FOR MERITORIOUS STUDENTS FROM CLASS XI TO POST GRADUATE COURSES)

- Students of Post Madhyamik levels and onwards in regular courses including Polytechnic courses; who are resident of West Bengal and studying in educational institutions of this state after passing out from the State Board/ Council of Secondary / Higher Secondary and Madrasah Education Board may apply subject to other eligibility criteria as stated below:-
- Applicants must be domicile of West Bengal and has been continuing education in institutes situated in West Bengal.
- Students must have passed his/her examination in current year i.e. 2018.
- The annual family income should not exceed **₹2.50 lakh (Certificate to be issued by an Officer not below the rank of Joint BDO)**
- Students are required to upload the original scanned documents.

POST-MATRIC STIPEND UNDER TALENT SUPPORT PROGRAM (TSP) (FOR POST-MATRIC CLASSES BELOW 50% MARKS)

- Students pursuing Higher Secondary, GRADUATION, POST-GRADUATION, M.Phil, Ph.D., etc. courses are eligible, except Professional and Technical course.
- Student should have passed with less than **50%** marks in the LAST FINAL exam and must be domicile of West Bengal
- Annual family income of the applicant should not exceed **₹2.00 lakh**
- Institute must be located within the state.
- Students will submit Photocopy of Bank Pass Book having account number & IFSC details, Annual family Income certificate issued by Pradhan/Councillor/MLA/Gazetted officer etc. along with the print out of online application to the institution only.

IMPORTANT INSTRUCTIONS FOR MINORITY SCHOLARSHIP

- Student must be a citizen of India and domicile in West Bengal.
- Students who are applying for the first time will have to submit application as FRESH candidate.
- Applicants in receipt of scholarship benefit last year and having a permanent ID must apply under **Renewal Category** only.
- A student is eligible for scholarship from any one source only.
- Distance Education applicants are likely to be rejected
- Registration must be done with one mobile number. However, relaxation for two registrations are allowed for pre-matric application only. All communication will be made to this number.
- The bank account must be an active account number.
- Students having AADHAAR number are advised to register with it, as preference will be given to AADHAAR seeded eligible students during disbursement.

EDUCATION LOAN (FOR HIGHER EDUCATION)

- Online applications are invited from students domiciled in WB pursuing Technical and Professional courses (Medical/Engineering/Law/Nursing/Diploma/Management/BCA/MCA etc).
