ii) Fresh student (s) will register at NSP Portal to get the Login Credentials and fill-up the entry form by entering complete details to get the Registration ID. All Renewal applicants/students (who have got scholarship during 2017-18) may apply by giving their existing Application ID;

iii) Aadhaar number/ Aadhaar Enrolment ID slip/ copy of request made for Aadhaar enrolment/ Bank passbook with photograph/ Ration Card/ PAN/ Passport/ Students ID/ Driving License are required as identification documents;

iv) Print out of the online application along with attested photocopies of supporting documents is to be submitted to the concerned institutes. The same set of documents shall also be submitted to the Directorate of Minority Affairs, if the same are not uploaded on the portal while submitting online application.

All Universities/Institutes/Colleges/Schools of the State, if not done earlier, are requested to register themselves and their course details on the NSP by 15<sup>th</sup> August, 2018 so that their students can apply and cause verifications of their applications on the portal without any delay.
