Applications (Fresh and Renewal) are invited from students who are permanent residents in the state of Meghalaya for the year 2018-19 for the following schemes.

1. **Pre Matric Scholarship for Scheduled Tribe students** is a Centrally Sponsored Scholarship Scheme administered by **Ministry of Tribal Affairs, Government of India**. Under this scheme scholarships are awarded to Schedule Tribe students of Meghalaya studying within the state from class IX - X in Government schools/institutes or private schools/institutes recognized by appropriate authority of the State are eligible subject to specified criteria. Annual income of both parents from all sources should not exceed ₹. 2.00 Lakhs p.a. Students must apply online in the dedicated National Scholarship Portal(NSP) under URL: <https://scholarships.gov.in>

**Last date for submission of Online application for Fresh and Renewal scholarship by students is 30<sup>th</sup> November, 2018..**

2. **Post Matric Scholarship for Scheduled Tribe students** is a Centrally Sponsored Scheme administered by Ministry of Tribal Affairs, Government of India. Under this scheme scholarships are awarded to Scheduled Tribe students of Meghalaya pursuing studies in different courses from class XI to Ph.D level in a recognized educational institution. Annual income of both parents should not exceed ₹ 2.50 Lakhs p.a for availing the scholarship. Students also are to maintain their own account in any Bank in which Core Banking System is operated. Students must apply online in the dedicated National Scholarship Portal(NSP) under URL: <https://scholarships.gov.in>

**Last date for submission of Online application for Fresh and Renewal scholarship by students is 30<sup>th</sup> November, 2018.**

3. **SCHEME OF CENTRAL SECTOR SCHOLARSHIP SCHEME FOR COLLEGE AND UNIVERSITY STUDENTS.** Applications are invited for students who are permanent residents of Meghalaya for the year 2018-19 for Central Sector Scheme of Scholarship for College and University students (Fresh & Renewal) to be awarded by the Ministry of Human Resource Development, Department of Higher Education, Government of India. . Annual income of both parents should not exceed ₹ 6.00 Lakhs p.a for availing the scholarship. Students must apply online in the dedicated National Scholarship Portal(NSP) under URL: <https://scholarships.gov.in>.

**Last date for submission of Online application for Fresh and Renewal scholarship by students is 31<sup>st</sup> October 2018.**

**Eligibility:**

- i. The student should be an Indian National.
- ii. The Applicant should have passed in Higher Secondary School Certificate Examination (HSSLC) 2017 conducted by MBOSE and secured a minimum of 80% marks and be in the Top 20 Percentile.
- iii. The renewal will depend on promotion to the next class provided the scholar secures 60% or more marks or equivalent Grade Point Average in aggregate for the two preceding semesters or of the annual examination which determines his promotion to the next class. Renewal is subject to discipline and maintenance of attendance of at least 75% by the scholar.
- iv. Pursuing a regular Course (not Correspondence or distance mode) from recognized institution.
- v. The Applicant should not belong to a creamy layer as defined by DoP&T from time to time.

Applications (Fresh and Renewal) are invited from students who are permanent residents in the state of Meghalaya for the year 2018-19 for the following schemes.

1. **Pre Matric Scholarship for Scheduled Caste students** studying within the state of Meghalaya from class IX upto class X in Government schools/institutes or private schools/institutes recognized by appropriate authority of the State. Annual income of Parents for Scheduled Caste students should not exceed ₹. 2.00 Lakhs p.a.
2. **Post Matric Scholarship for Scheduled Caste students** who are pursuing higher studies in different courses from class XI to Post Graduation. Annual income of Parents for Schedule Caste Students should not exceed ₹. 2.50 Lakhs p.a.
3. **Free Studentship Scholarship for Scheduled Tribe/Scheduled Caste students** who are pursuing higher studies in different courses from class XI to Post-Graduation. Students who failed in the previous year and also those students who are not eligible to apply for Post Matric Scholarship for Schedule Tribe/Schedule Caste due to their parents income exceeds ₹ 2.50 lakhs per annum are eligible to apply for this Scholarship.
4. **Book Grant Scholarship for Scheduled Tribe students** who are pursuing higher studies in different courses from class XI to Post-Graduation (excluding Vocational, Engineering, Medical & Paramedical courses) and who secured marks 60% and above at previous year examination are eligible to apply for the Book Grant Scholarship.
5. **Merit Scholarship for Tribal and General Students:** Applications are invited from the Schedule Tribe and General Students of Meghalaya who has secured very high percentage of marks in Class X, XII (MBOSE, AIICSE & CBSE) and Degree Examination 2018 for a specific number of Merit Scholarships to be chosen Merit Wise.
6. **Post Graduate Research Scholarship** for the students of Meghalaya (SC/ST and General) who are doing research courses in University or Research Institutions for M.Phil or Ph.D and who secured 50% marks and above at Master Degree level are eligible to apply for the Scholarship.

7. **Basic Science Scholarship for College and University level:**

1. **Target Group:** The students who pursue higher education in pure science stream and have honours in one of the subject as mention in point 6 of this advertisement and are admitted to various non professional UG/PG/PHD courses in Universities / Colleges may also apply for scholarship under the aforesaid scheme.

This scheme is not for students who pursue higher education in Applied Science such as Engineering, Medical, Agriculture, Architecture, Bio-Technology, Bio Medical, BSc-Nursing, Computer Application, Allied Medicine etc.

2. **Eligibility:** Only candidates belonging to Meghalaya who are Permanent Residences and fulfill all other eligibility criteria and conditions will be considered for financial support under the scheme.

**Eligibility criteria and conditions of the Scheme will be as follows:**

The scholarships are open to Permanent Resident of Meghalaya State only.

- (a) Students should have not less than 45% marks at higher secondary/ graduation level/post graduation. Selection of these students will be done strictly on merit basis.
- (b) The annual income of the beneficiary/parent or guardian of beneficiary should not exceed ₹4.50 lakh from all sources.
- (c) These scholarships will be given for the study in Science all recognized UG/PG/Ph.D courses pursued in recognized institutions.
- (d) Only those candidates who belong to Meghalaya State i.e. permanently settled and who have passed the 10+2 or any higher secondary examination of a recognized University or Board of Secondary Education in science stream and pursuing the same will be eligible.
- (e) Students pursuing part-time courses/ correspondence courses will not be eligible.
- (f) All children of the same parents/guardians will be entitled to receive benefits of the scholarships scheme.

3. **Physical Target:** Every year 1000 scholarships will be distributed among the students pursuing Basic Science according to their merits and parental income from BSc. till P.hD level throughout the State of Meghalaya. Base on the distribution of scholarship, the number of applicants for which the scholarship will be awarded will be for B.Sc 1<sup>st</sup> yr.-215, B.Sc 2<sup>nd</sup> yr.-215, B.Sc 3<sup>rd</sup> yr.-215, M.Sc 1<sup>st</sup> yr.-150, M.Sc 2<sup>nd</sup> yr.-150, Ph.D-55.

4. **Selection Procedure:** Applicant will be selected base on class 12 result, if there is a tie in class 12 percentage between applicants, English subject will be a tie breaker else Parents income will be taken into consideration.

**Note:** If the number of the students applied for this scholarship scheme exceeds the Physical target, the scholarship will be restricted to that number of students who occupied top slots in the merit list.



5. **Cancellation of Scholarship:**

DHTE may terminate scholarship of any student in case of:

- (a) Misconduct of the awardees, if any, reported by the University/College/Institution.
  - (b) Unsatisfactory progress report i.e. if the candidate scores less than 45 % marks in the first year of Bachelor's/ Master's programme (40 % in case of Physically Challenged awardee)
  - (c) Candidates being found ineligible at a later date shall face the penal action and will also be liable to refund the entire scholarship amount paid.
6. Undergraduate and postgraduate courses under Basic Science scholarship scheme are Physics, Chemistry, Mathematics, Botany, Zoology.

7. **How to Apply:** Applicants may apply through application forms only which may be collected from their respective institutes and the duly filled in application should be submitted to the institute. Individual application forms will be issued and accepted only for students studying outside. The forms may also be downloaded from the website of Director Higher & Technical Education, Meghalaya, megeducation.gov.in. All the Principals submitting the application forms should submit alongwith the soft and hardcopy in excel format

**Eligibility:**

- a) The student should be a permanent resident of Meghalaya.
- b) He/She belongs to ST Community of the State of Meghalaya.
- c) He/She is pursuing a regular course of Studies in any recognized institution.
- d) His /Her guardian/parent are citizens of India.
- e) That He/She is not employed in any service under the Government or any Non-government establishment.
- f) He/She is not a repeater in the same class.

All Principals submitting the application forms should submit along with the soft copy.

The last date of submission of application forms will be on or before the **30<sup>th</sup> November 2018**.

No application form will be entertained after the above specified date.
