## Female Student Scholarship: Means Based

Type of scholarship:	This is a <b>means based scholarship</b> available to eligible female students for the full duration of the program (five years) subject to successful completion of each semester's full course work in first attempt.
Eligibility:	Female students successfully admitted to Bachelor of Architecture program in 2018 with total family income less than <b>Rs. 10 lakhs per annum</b> are eligible to apply.
Announcement of Scholarship:	All admitted students of B. Arch program will be informed about this scholarship in the end of September 2018.
Process of Application:	Interested and eligible students will have to submit the scholarship application form to scholarship committee, along with required documents on or before scheduled date and time.
Documents required:	<ul> <li>Applicant must submit the documents listed below along with the scholarship application form:</li> <li>Income Tax Return Financial Year 2017-18 Assessment Year 2018-19 of all the earning family member is to be produced</li> <li>If the parent/guardian is not filing IT Returns and is having land/or is a farmer, Income proof certificate from Gram Panchayat / Mamlatdar / Choro / Creamy layer certificate to be provided of Financial Year 2017-18.</li> <li>Bank Statement of Financial Year 2017-18</li> <li>Income declaration by parents/guardians, stating definite income as per the Income tax return Financial Year 2017-18 from all sources by way of an affidavit on non-judicial stamp paper is required.(as per given Format of Affidavit)</li> </ul>
Selection Process:	<ol> <li>All eligible female students are put in an ascending order of family income (lowest income first).</li> <li>If more than one student have the same income level, their rank in the admission merit list will be used as 1<sup>st</sup> tie breaker and their percentage score in qualifying board exam will be used as the 2<sup>nd</sup> tie breaker.</li> <li>The female student who tops this list becomes the awardee student.</li> </ol>

Benefit:	<ul> <li>One awardee student will receive scholarship of:</li> <li>a) 50% of the annual tuition fee every year OR</li> <li>b) Rs. 1.50 lakhs every year, whichever is less. This scholarship will be awarded for maximum five years (from 2018-19 to 2022-23), given the renewal criteria are fulfilled.</li> </ul>
Renewal:	From second semester and onwards, an awardee of Mean Scholarship must successfully complete full course-work (pass all the courses she has registered for), and achieve C grade (Grade point 2), in the previous semester, in order to be eligible for renewal of Scholarship.
Suspension:	<ol> <li>Failure to fulfil renewal criteria.</li> <li>Serious disciplinary or plagiarism charge proved against the awardee student.</li> </ol>
Transfer of benefit:	If the awardee student's benefit is suspended, the next applicant in the scholarship merit list (given that she is not a recipient of any other scholarship/ grant) will receive the benefit for the remaining duration (till 2022-23).
Scholarship committee:	The committee comprises Registrar, Academic Director, Director Admissions, Director Strategic Planning and Director of Alumni Office.
Award of scholarship:	In the first semester it will be reimbursed after admissions are over.
