- 1. 10+/Diploma course from ITIs.
- 2. B.Sc/B.Com/B.A etc.
- 3. B.E/B.Tech
- 4. MBBS
- Amount of Meritorious Scholarship:

Eligibility

- For 10+/ITI/Diploma Scholarships, students securing a minimum of 85% marks in their 10th and 12th standard examinations or equivalent apply.
- For Degree Courses, students securing a minimum of 85% marks in their 12th standard examination or equivalent and having a confirmed admission into a full time degree course.
- c) For Engineering Scholarship Students securing a minimum of 85% marks in their 12th standard examination or equivalent and having a confirmed admission into a full time Engineering Degree course.
- d) For MBBS Scholarships- Students securing a minimum of 85% marks in their 12th standard examination or equivalent and having a confirmed admission into a full time MBBS Degree course.
- The minimum and maximum age limits are 15 years and 25 years respectively.
- The Student should not avail any other scholarship facilities from any institute/Government.
- The selection will be made on the basis of the criteria laid down in the "NEEPCO MERITORIOUS" SCHOLARSHIP SCHEME" of the corporation. The decision of the corporation in this regard shall be final.
- h) 3 (three) percentage Bonus marks shall be added in case of female applicants for selection for award of the Scholarship.
- 5 (five) percentage Bonus marks shall be added in case of Physically Handicapped / Differently Abled applicants for selection for award of the Scholarship.

- 2. A copy of self-signed recent passport size photograph to be affixed in the place provided in the Application Form.
- 3. True copy of Pass certificate, Mark- sheet in respect of last examination passed should be enclosed along-with the application. Original certificates should not be sent unless called for and NEEPCO will not take responsibility for loss of original documents, if sent without calling for.
- 4. A copy of certificate from the Competent Authority certifying the degree of Disability in respect of Physically Challenged / Differently Abled (VI- Visually Impairment, HI- Hearing Impairment & LD-Loco motor Disability) wards should be enclosed along-with the application.
- 5. The fields of Employee Code of the applicant parent, Bank Account No. of the applicant, Bank Name, Branch Name & IFSC Code in the application form are mandatory. All the fields in the form are mandatory. In complete application shall be summarily rejected.
- 6. Any advance copy of the application sent to this office via email will not be considered for Scholarship unless the hard copy is sent. The Corporate Welfare Section will not be responsible, for any application sent via email.
- 7. The hard copy of the application (officially) along with the relevant testimonials should reach this office latest by 31st October, 2018. Applications received thereafter shall be summarily rejected. The applications will be considered on "first come first serve basis".
- 8. Wards of employees who are either new applicants or progressive applicants has to apply along with all relevant testimonials in Form Annexure 'C' and Annexure 'D' respectively within the stipulated time and any applications received after the prescribed time, will not be entertained.
- Any application received (New or Progressive) pertaining to previous year (backlog applications) will not be eligible for Scholarship, NEEPCO shall not be responsible for loss of testimonials, if sent without calling for.
- 10. In terms of Clause V of the NEEPCO Meritorious Scholarship Scheme the wards of NEEPCO employees are only eligible for the grant of Scholarship and Heads of HR of respective Projects/Offices shall take into account the same while forwarding the applications to Corporate Welfare Section.
