In accordance with the INTACH Memorandum of Association and in the honour of Charles Wallace,

Most scholarships are awarded to professionals in the early stages of their career, or to students. Senior travel scholarship are also available. The scholarships or part thereof could also be offered to any charitable educational institution in India facilitating the above education study visits.
