

#### Documents to be furnished:-

1. A certificate/letter to the effect that you have joined the Institution/ College/University you have opted for higher studies abroad.
2. A Xerox copy of the Visa issued by the country you have proposed for higher studies.
3. Candidate has to produce a certificate for receipt or non-receipt of any scholarship /Allowances from the College/University/Government from the place of his study abroad.
4. A Xerox copy of the boarding pass for having travelled to that Country/ Air ticket.
5. An agreement in a Non-Judicial stamp paper of Rs. 200/- (in the enclosed Proforma, duly notarized) to the effect that the amount of Scholarship granted to you will be utilized for the higher education abroad only. In case you discontinue your studies without intimating to this office, the amount will have be refunded to the Minority Department with interest if any.
6. A surety bond in Non-Judicial stamp paper of Rs. 200/- (in the enclosed Proforma) duly notarized from your two nearest relatives or Persons known to you other than family members to the effect that they will stand surety to the Scholarship amount granted to you for higher Studies.
7. Xerox Copy of Students Bank Pass Book.(please submit only if there is any Change of Bank)
8. Submit your Institution/College/University ID Card Xerox Copy.
9. IT Returns Financial Year (1.04.2018 to 31.03.2019), Assessment year (2019-20)/ Affidavit to declare whether you are IT assessee or not of self (Candidate), Parents (father & Mother), guardian to submit if not submitted.
10. Those candidates who's Offer letter are incomplete like start of course, Duration of Course, End date of course completion, fees structure with food & accommodation may submit without fail.
11. If above documents are not submitted by the candidate in such cases scholarship amount will not be credited to you.
