The combination available in our vidyalaya is **Maths, Physics, Chemistry with Computer Science OR Hindi** (any one) along with Compulsory Language English(Core). No regional language or any other subject can be provided as an additional subject or as main subjects.(**Annexure-III**)
05. **Usage of electronic items like Mobile phone, SIM card, digital camera, apparatus, Electronic gadget etc., are strictly prohibited. In case anyone is found with any of these items, he/she will be terminated immediately & send back to parent vidyalaya. (Annexure IV)**
06. Willingness from the Student & Parent to join the course and to stay in JNV Bangalore Urban for a period of 2 years till the completion of the course. (**Annexure V**)
07. **Name, address and photo of a local guardian should be submitted in duplicate at the time of admission. (Annexure VI)**
08. The proposed visitors name, address & their relationship to the students are to be mentioned. (**Annexure VII**)
09. Only those visitors will be allowed to meet the students. **Parents will not be permitted stay in the campus. Allowed to see the student concerned from morning till evening only on 2nd Saturday/4th Sunday with prior intimation**
10. **A Non Judicial Stamp Paper of Rs.20/- must be brought with printout of enclosed matter and signed by the witness while reporting. (Annexure VIII)**
11. Admission abstract (Very important)
12. Family income Certificate for the year 2020.

13. Caste Certificate duly attested (obtained on or after 01.01.2020) and those who have life time certificate can submit the same.
14. Original & Xerox copy of the Aadhar Card.
15. Cumulative Record (wherever maintained original to be sent)
16. Health Card(Original to be sent & Xerox Copy may be retained in the parent Vidyalaya)
17. Xerox copy of VI class Bio-data & application of admission duly attested by Principal of Parent Vidyalaya.

29. **Navodaya Vikas Nidhi (NVN) Fee , as per NVS Norms**, should be deposited at the time of admission at JNV Bangalore Urban (Rs.1500 per month whose parents are Govt. Employees and Rs.600 per month for others). In case of fee exemption, required documents to be submitted at the time of admission [Income Certificate & BPL Certificate]
30. After the completion of the course, the individual student has to submit No dues Certificate in duplicate (one for this Vidyalaya & the other for parent vidyalaya) for the **issue of Transfer Certificate (TC) by the Parent Vidyalaya after the completion of the Course.**

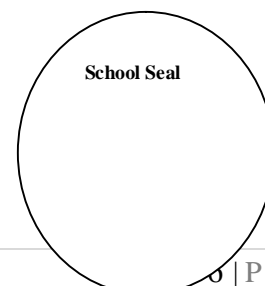

_____ (herein after called as guarantor which expression shall, unless excluded by the context or the meaning thereof, deemed to include his/her heirs, executors, administrators & legal representative), as one part and Navodaya Vidyalaya Samiti, Noida (herein after called the Samiti which expression shall unless excluded by the context of the meaning thereof, be deemed to include the principal Jawahar Navodaya Vidyalaya, Bagalur, Bangalore Urban Dist. , Karnataka on the other part.

Whereas Master / Kumari _____ (herein after called the student), Son/Daughter of Sh. _____ is ward of the Guarantor and been selected through test [NDST] for admission to Jawahar Navodaya Vidyalaya, Bagalur State: Karnataka, interalia, on the terms and conditions herein after appearing, for the purpose of receiving education.

Now it is hereby agreed upon by & between both the parties hereto as follows in order to get admission to the aforesaid institution:-

(A) That in consideration of the student being completing all the formalities/fulfilling all the conditions & producing all the desired documents, is being admitted by the Samiti to the Jawahar Navodaya Vidyalaya, Bagalur ,State :Karnataka regularly and will observe and comply with all the rules and regulations thereof for the prescribed period ,i.e. upto XII standard of studies in the said vidyalaya.

(B) That if after the admission of student any of the following documents viz. proof of residence, proof of Age, School leaving certificate, Medical certificate & all other documents provided by the candidate/parents or information's supplied by the Guarantor at the time of admission is found to be false in any way or not in order or forged, the student will be expelled from the school with immediate effect & the guarantor shall forthwith pay to the Samiti the total Expenditure incurred by the Samiti.

(C) That if the guarantor withdraws his/her ward from the said vidyalaya before the completion of his/her studies on grounds other than genuine medical ground which shall be certified by the Chief Medical Officer/Civil Surgeon of govt. hospital, the guarantor shall be liable to pay the for the expenditures incurred on his/her ward.

2. That the Samiti/JNV Bangalore Urban or its any of the staff members will not be liable for any damages/Charges/claim on account of injuries, fatal or otherwise which may be sustained by the student at any time during his/her stay in JNV, Bangalore Urban while taking part in Sports, NCC, Co-Curricular activities or any other form of activities of the vidyalaya, within or outside the vidyalaya premises, educational tours, excursion, treks, journey undertaken through any mode of transport/travel. All expenses that may be incurred in treatment of such injuries or illness of the student shall be borne by the Guarantor/Parents/Guardians as provided in the rules of the said school.

3. That the Samiti can in the larger interest of the school have the student removed from the school if, in the Samiti's opinion, the student has failed to abide by the rules of the school/indulged in abusing or manhandling with any of the students or staff members/indulged in teasing Junior students in any form/abusive towards his/her classmates & house mates/showing disrespect towards girl-students or ladies/indulged in the activity of grouping & instigating students against any other student or against any particular class of students or teachers or any of the staff members or school administration. That the Samiti can in larger interest of the school have the student sent back to his parent Vidyalaya if the student fails to come up to minimum academic standard of his/her class or fail to adjust with the academic/health/other issues.
4. That if the student causes damage to any of the property of the school willfully/accidentally/or otherwise, wholly or partially, individually or in a group, the fine as imposed by the School on individual or in a group, guarantor shall forthwith pay to the school , the amount as fixed. In case of repetition of such things the act will be treated as willful act of indiscipline and the student can, in the larger interest of the school, be removed from the school, the guarantor shall pay the Loss towards the damage.
5. That the Guarantor shall drop his/her ward in vidyalaya premises at the time of joining and after availing leave granted on medical/genuine ground, personally or through his/her authorized representative & also collect personally or through his/her authorized representative for leave/ after completion of the course & shall be personally responsible for any untoward incident on the way. Further he will report in the vidyalaya on every call from Vidyalaya authorities on date & time as fixed by them. The guarantor shall pursue his/her ward to accept & comply the rules & regulation of the Vidyalaya/NVS. The guarantor shall nominate a local guardian to report the Vidyalaya on emergency. Guarantor shall also not compel the authorities concerned to leave his/her ward /to take home for purposes like to attend marriage etc. in relationships, Celebrations of his/her own or kins' birthday, Pooja, festival etc. The guarantor shall report the Vidyalaya in time and ensure that he/she will accompany the students to the Examination Center to appear for the Entrance/Competitive Examination to be held during the period of stay.
6. That the Guarantor shall ensure that his/her ward does not keep with him/her any of the items like mobile phones, Sharp edged weapons, knife, Arms & ammunitions, Stove, Heater, other electrical or electronic gadgets, electrical/electronic shaving or trimmer sets, Utensils (Except Plate , tumbler , bucket & Mug), Music System, radio set, Jewellery Agarbatti, Candles, Match Box or any inflammable items like crackers or explosives, lighter, tool kits etc or life-threatening items like poison, insecticide, etc which are non-permissible in Jawahar Navodaya Vidyalaya, Bagalur, Bangalore Urban district.
7. That the guarantor shall visit the school time to time on the days fixed for the purpose & meet the teachers/housemasters to keep him/herself apprised of the academic progress & other activities regarding his/her ward. He will deposit the Cash with the Housemaster only to provide to his/her ward in need. He will not provide any amount of cash to his/her ward to keep with him/her.

8. If the student leaves the vidyalaya premises/campus without permission of the Housemaster/Principal/ any authorized person, None of the staff members of the school will be responsible, in any way, for any loss/damage caused to him/her physical or fatal or otherwise.
